3. Subject to Ludhiana Jurisdiction only.
4. Booking Procedure/Payment Schedule: Exhibitor has to fill the Requisite/Booking Form, along with **30% ADVANCE PAYMENT , NON REFUNDABLE** at the time of booking and balance Full and Final Payment **STRICTLY** by **31st December, 2025** has to be made in any case, otherwise booking made will be treated as **CANCELLED**.
5. Organizers reserve the right to cancel or postpone the Exhibition, in whole or in part (including individual stalls), due to unforeseen circumstances, government directives, natural disasters, or national/international crises. They shall not be held responsible for any resulting loss, and their decision—whether to carry forward any advance payments by participants/vendors in full or in part—shall be final and binding.
6. Exhibitor has to Clear all the Dues to get Allocation Letter from the organiser, only after getting the Allocation Letter Exhibits Move in will be allowed.
7. Any area occupied beyond the allocated or applied space at the time of booking will not be permitted. Exhibits placed outside the designated stall area are subject to removal by the Organisers.
8. No Hoardings/Standies/Hands Bills or advertisement by any other media can be displayed without permission from the Organisers. Exhibitor can adopt any advertisement media provided by the organisers on the paid terms, details can be obtained from GMSA EXPO office.

Exhibitors if applied for **Bare Space** have to get approval for the design of booth before hand to avoid last minute changes, **height restrictions are 12 Feet**, beyond this height cannot be exceeded, Power connection is to be applied for Stall Lighting & Exhibits. Exhibitor will be responsible for waste material removal and the sides towards neighbouring stalls has to be finished at your cost.
11. Any Sublet/transfer/sharing with member-non member of the booked booth/stall by the exhibitor will not be allowed/entertained. Therefore for any apprehension last Decision will be of the Organizer.
12. Possession for Construction of Customise Stall will be from **1st to 4th February, 2026**. Thereafter **NO** working will be allowed. Timings **9:00 AM to 9:00 PM** for all four days.
13. Move in Machinery will be allowed from **10:00 AM 3th Feb. 2026** to **8:00 PM 4th Feb. 2026**. Move Out of Machinery **10th February, 2026, 10:00 AM To 8:00 PM**.
14. Timing for Exhibitors:10:00 AM to 8:00 PM for all four days.
15. Timing for Visitors:10:30 AM to 7:00 PM for all four days.
